APPROVAL OF SUMMARY OF CHECKS WRITTEN – ALL FUNDS, APRIL 2014: Board Member Dodds, seconded by Board Member La Due, moved to approve and place on file the summary of checks written. April 2014 showed the total for the Town Fund was \$35,882.36; General Assistance was \$10,465.61; IMRF was \$4,492.83 and the Social Security Fund was \$568.14. Total expenditures for the month of April 2014 were \$51,408.94. A voice vote was taken on the motion to approve expenditures; all voted yes. Motion carried.

ORDINANCE 14-0601: AN ORDINANCE FOR THE TOWN OF THE CITY OF CHAMPAIGN, CHAMPAIGN COUNTY, ILLINOIS ASCERTAINING THE PREVAILING WAGES RATE FOR LABORS, WORKERS, AND MECHANICS EMPLOYED ON PUBLIC WORKS OF SAID TOWNSHIP: Board Member Dodds, seconded by Board Member La Due, moved to adopt the Ordinance. A roll-call vote was taken on the motion; all voted yes. Motion carried.
