



**RESOLUTION 2009-1101**  
**A RESOLUTION DETERMINING THE AMOUNTS OF MONEY**  
**NECESSARY TO BE RAISED BY THE TAX LEVY**

**WHEREAS**, an Act to provide procedures for the public notice and hearing on tax levy increases, as adopted by the General Assembly of the State of Illinois, became effective on July 29, 1981; and

**WHEREAS**, said Act requires taxing districts, including the TOWN OF THE CITY OF CHAMPAIGN, to disclose by publication and hold a public hearing on their intention to adopt an aggregate levy in amounts more than 105% of the property taxes extended or estimated to be extended upon the levy of the preceding year; and

**WHEREAS**, Section 4 of said Act requires the corporate authority of each taxing district, not fewer than twenty (20) days prior to the adoption of its aggregate levy, to determine the amounts of money, exclusive of any portion of that levy attributable to the cost of conducting any election required by the general election law, estimated to be necessary to be raised by taxation for that year upon the taxable property in its district; and

**WHEREAS**, if the estimate of the corporate authority required to be made as provided in Section 4 of said Act is more than 105% of the preceding year, exclusive of election costs, Section 6 of said Act requires the corporate authority to give public notice of and hold a public hearing on its intent to adopt a levy which is more than 105% of the extensions, exclusive of the election costs, for the preceding year.

**NOW THEREFORE BE IT RESOLVED BY THE BOARD OF TOWN TRUSTEES OF THE TOWN OF THE CITY OF CHAMPAIGN, CHAMPAIGN COUNTY, ILLINOIS**, as follows:

1. That the Board of Town Trustees of the Town of the City of Champaign, Champaign County, Illinois, hereby determines that the amounts of money, exclusive of any portion of the aggregate tax levy attributable to the cost of conducting an election required by the general election law, be and the same is hereby estimated to be \$560,413 which said amount is to be raised by taxation for the current year upon the taxable property in the Town of the City of Champaign.

2. That the aggregate amount of property taxes for the Town of the City of Champaign, extended upon the levy of the preceding year, exclusive of election costs, was \$518,461.

3. That the estimate of \$560,413 to be levied for the current year is 8.09 % of the \$518,461 extended upon the levy for the preceding year, exclusive of election costs.

4. That a public hearing on the Board of the Town Trustees' intention to adopt an aggregate levy in an amount more than 105% of the property taxes extended through the final aggregate levy, exclusive of election costs, of the preceding year shall be scheduled for December 1, 2009 at 7:00 p.m.

5. That notice of the proposed levy and the planned public hearing shall be published in *The News-Gazette* between November 17, 2009 and November 23, 2009.
