APPROVAL OF REGULAR MEETING MINUTES: Board Member Dodds, seconded by Board Member La Due, moved to approve the minutes of the Regular Meeting of July 6, 2010. A voice vote was taken on the motion to approve the minutes; all voted yes. Motion carried.

APPROVAL OF SUMMARY OF CHECKS WRITTEN – ALL FUNDS, JUNE 2010: Board Member Dodds, seconded by Board Member La Due, moved to approve and place on file the summary of checks written. June 2010 showed the total for the Town Fund was \$33,989.86; General Assistance was \$5,632.50; IMRF was \$1,978.16; and the Social Security Fund was \$1,712.52. Total expenditures for the month of June 2010 were \$43,313.04. A voice vote was taken on the motion to approve expenditures; all voted yes. Motion carried.

QUARTERLY FINANCIAL REPORT, FOURTH QUARTER FY 09/10: Board Member Dodds, seconded by Board Member La Due, moved to approve and place on file the Fourth Quarter FY 09/10 Quarterly Financial Report. A voice vote was taken on the motion to approve and place on file the report; all voted yes. Motion carried.

QUARTERLY GA-TA REPORT, FOURTH QUARTER FY 09/10: Board Member Dodds, seconded by Board Member La Due, moved to approve and place on file the Quarterly GA-TA Fourth Quarter FY 09/10 Report. Board Member Dodds noted there were 150 walk-ins but only six new clients, and questioned why only six were accepted. Township Supervisor Borowski explained the program is transitional assistance program,

and very few of the walk-ins qualify because the program covers the time between having applied for SSI benefits and actually receiving SSI benefits. A voice vote was taken on the motion to approve and place on file the report; all voted yes. Motion carried.
