



**ORDINANCE NO. 2011-1201**

**AN ORDINANCE LEVYING TAXES FOR ALL TOWNSHIP  
PURPOSES FOR CITY OF CHAMPAIGN TOWNSHIP,  
CHAMPAIGN COUNTY, ILLINOIS  
FOR THE TAX YEAR 2011, COLLECTIBLE IN 2012**

BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE CITY OF  
CHAMPAIGN TOWNSHIP, CHAMPAIGN COUNTY, ILLINOIS, as follows:

Section 1. That the sum of five hundred and sixty six thousand, eight hundred and ninety dollars and no cents (\$566,890.00) is hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law for such purposes as:

- General Town Fund
- General Assistance Fund
- Social Security Fund
- Illinois Municipal Retirement Fund

for the year 2012.

Section 2. That the amount levied for each object and purpose shall be as follows:

validity of the remaining portion of this Ordinance.

Section 5. That this Ordinance shall be in full force and effect after its adoption, as provided by law.

Section 6. That the Town Clerk is hereby directed to send a copy of this Ordinance to Pamela K. Borowski, Supervisor of the City of Champaign Township, and to Frederick Stavins, Township Attorney.
