APPROVAL OF REGULAR MEETING MINUTES: Board Member Dodds, seconded by Board Member La Due, moved to approve the minutes of the Regular Meeting of May 3, 2011. A voice vote was taken on the motion to approve the minutes; all voted yes. Motion carried.

Total expenditures for the month of April 2011 were \$58,949.66. A voice vote was taken on the motion to approve expenditures; all voted yes. Motion carried.

ORDINANCE 11-0601: ANNUAL BUDGET AND APPROPRIATION ORDINANCE: Board Member Dodds, seconded by Board Member La Due, moved to approve and place on file the Annual Budget and Appropriation Ordinance. A roll-call vote was taken; all vote yes. Motion carried.

ORDINANCE 11-0602: AN ORDINANCE OF THE TOWN OF THE CITY OF CHAMPAIGN, CHAMPAIGN COUNTY, ILLINOIS ASCERTAINING THE PREVAILING WAGE FOR

LABORERS, WORKERS, AND MECHANICS EMPLOYED ON PUBLIC WORKS OF SAID TOWNSHIP: Board Member Dodds, seconded by Board Member La Due, moved to approve and place on file the Prevailing Wage Ordinance. A roll-call vote was taken; all voted yes. Motion carried.
