APPROVAL OF MINUTES: Board Member Dodds, seconded by Board Member La Due, moved to approve the minutes of the Regular Board Meeting of April 1, 2014. A voice vote was taken on the motion to approve the minutes; all voted yes. Motion carried.

PUBLIC HEARING: None

APPROVAL OF SUMMARY OF CHECKS WRITTEN – ALL FUNDS, MARCH 2014: Board Member Dodds, seconded by Board Member La Due, moved to approve and place on file the summary of checks written. March 2014 showed the total for the Town Fund was \$39,788.19; General Assistance was \$11,761.51; IMRF was \$4,492.83 and the Social Security Fund was \$568.14. Total expenditures for the month of March 2014 were \$56,610.67. A voice vote was taken on the motion to approve expenditures; all voted yes. Motion carried.

QUARTERLY GA-TA REPORT, THIRD QUARTER, FY 13/14: Board Member Dodds, seconded by Board Member La Due, moved to approve the quarterly third quarter report. A voice vote was taken on the motion to approve the third quarter report; all voted yes. Motion carried.

AUDIENCE PARTICIPATION: None

TOWN BOARD AND TOWNSHIP SUPERVISOR'S COMMENT: Supervisor Quarnstrom noted staff is working on the budget, and he is excited about the possibility of including new programming. Last week was Lobby Day for the Township Officials of

Illinois (TOI), and he participated in lobbying local legislators regarding issues important to Township government. He noted there is legislation that could be detrimental to Townships like Champaign, but are currently stalled. Supervisor Quarnstrom noted he and staff have been reviewing the General Assistance (GA) program, reviewing and editing language in the manual, updating documents, and ensuring the office is up-to-date with statutes regarding GA.

NEXT MEETING: Chairman Gerard noted the next meeting would be the Regular Town Meeting of June 3, 2014.
