

**ORDINANCE NO. 2011-0501**

Transfer of Appropriation Ordinance,  
City of Champaign Township  
(May 2011)

Whereas there was adopted on June 8, 2010, by the Town Board of the City of Champaign Township in the County of Champaign, State of Illinois, a budget and appropriation ordinance for the fiscal year beginning July 01, 2010, and ending June 30, 2011:

And whereas it now appears that certain adjustments between appropriation items in the Town Fund in said ordinance are desirable and necessary;

And whereas Section 3 of the Illinois Municipal Budget law (50 ILCS, 330/3), approved on July 12, 1937, as amended, authorizes transfers between the various items within any fund in such appropriation ordinance not exceeding in the aggregate 10 percent of the total amount appropriated in such fund by such ordinance.

Now therefore, be it ordained by the Town Board of the City of Champaign Township, in the County of Champaign, State of Illinois;

Section 1. TOWN FUND ADMINISTRATION

That there is hereby transferred from the Town Fund Administration Professional Services line item (02-01001-730) (balance \$5,100.00), the amount of \$1000 to the Town Fund Administration Professional Memberships line item (02-01001-712), (balance -\$482.00) making the adjusted appropriation for the Town Fund Administration Professional Services fund \$4,100.00 and the adjusted appropriation for the Town Fund Administration Professional Memberships fund \$518.00.

That there is hereby transferred from the Town Fund Administration Postage and Express Charges line item (02-01001-725) (balance \$750.00), the amount of \$250 to the Town Fund Administration Disposal and Recycling Services line item (02-01001-722), (balance -220.00) making the adjusted appropriation for the Town Fund Administration Postage and Express Charges fund \$500 and the adjusted appropriation for the Town Fund Administration Disposal and Recycling Services fund \$30.00

Section 2. TOWN FUND ASSESSOR

That there is hereby transferred from the Town Fund Assessor Motor Vehicle line item (02-02001-640) (balance \$500.00), the amount of \$200 to the Town Fund Assessor Office Supplies line item (02-02001-600), (balance -\$200.00) making the adjusted appropriation for the Town Fund Assessor Motor Vehicle fund \$300.00 and the adjusted appropriation for the Town Fund Assessor Office Supplies fund \$0.00.

That there is hereby transferred from the Town Fund Assessor Utilities line item (01-01001-740) (balance \$3,000.00), the amount of \$300 to the Town Fund Assessor Misc Contractual Services line item (02-02001-740), (balance -\$300.00) making the adjusted appropriation for the Town Fund Assessor Utilities fund \$2,700.00 and the adjusted appropriation for the Town Fund Assessor Misc Contractual Services fund \$0.00

Section 3. These transfers shall be in full force and effect from this date forward.
