APPROVAL OF SUMMARY OF CHECKS WRITTEN – ALL FUNDS, FEBRUARY 2016: February showed the total for the Town Fund was \$50,106.53; General Assistance was \$28,863.50; IMRF was \$4,418.79 and the Social Security Fund was \$587.68. Total expenditures for the month of February 2016 were \$83,976.50. Board Member Bruno, seconded by Board Member La Due, moved to approve the expenditures. Supervisor Quarnstrom noted a slight increase of expenditures with the expense of relocating Township Offices. A roll-call vote was taken on the motion to approve the expenditures; all voted yes. Motion carried.

Martin Tomack, 315 Cottage Crt., addressed the Board regarding Feeding Our Kids (feedingourkids.org), founded by two local parents in November 2013. He noted the purpose of the organization. He indicated participating with the U of I day of Service in packing food this week; and encouraged the public to contact the organization about volunteering or donating food.
