

ORDINANCE NO. 2016-1202

**AN ORDINANCE LEVYING TAXES FOR ALL TOWNSHIP PURPOSES FOR CITY OF CHAMPAIGN TOWNSHIP,
CHAMPAIGN COUNTY, ILLINOIS FOR THE TAX YEAR 2016, COLLECTIBLE IN 2017**

WHEREAS, the Township Trustees of the City of Champaign Township, Champaign, Illinois did on the 7th of June, 2016, duly adopt the Annual Budget for the said Township for the fiscal year beginning July 1, 2016 and ending June 30, 2017; and

WHEREAS, the Township Trustees have directed that the Township's property tax levy (exclusive of any amount levied for election cost or debt service purposes) for the upcoming year would be \$622,134, such estimated levy being based upon estimated assessed valuation being \$1,563,574,567;

BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE CITY OF CHAMPAIGN TOWNSHIP,
CHAMPAIGN COUNTY, ILLINOIS, as follows:

Section 1. That the sum of six hundred twenty-one thousand, one hundred and thirty-four dollars and no cents (\$622,134) is hereby levied upon all property subject to taxation with the Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law for such purposes as:

- General Town Fund
- General Assistance Fund
- Social Security Fund
- Illinois Municipal Retirement Fund

For the year 2017.

Section 2. That the amount levied for each object and purpose shall be as follows:

Section 5. That this Ordinance shall be in full force and effect after its adoption, as provided by law.
