APPROVAL OF SUMMARY OF CHECKS WRITTEN – ALL FUNDS, MAY 2018: May showed the total for the Town Fund was \$46,879.77; General Assistance was \$10,877.80; IMRF was \$3,988.78; and the Social Security Fund was \$629.24. Total expenditures for the month of May 2018 were \$62,375.59. Board Member Stock, seconded by Board Member Bruno, moved to accept and place on file the summary of expenditures. Supervisor Quarnstrom noted no significant expenditures. A voice vote was taken; all voted yes. Motion carried.

TOWN BOARD AND TOWNSHIP SUPERVISOR'S COMMENT:

Supervisor Quarnstrom noted there will be a Special Town Meeting on July 17, 2018 to discuss the budget; and the next regular meeting is August 7, 2018. In addition, he briefly addressed the rental assistance program which provides assistance to those that are facing eviction with a 10 day notice or are homeless; noted the program mirrors that of

Cunningham Township; and how the program cost will result in increased cost in the summary expenditures. He noted the rental assistance program has a strong vetting process, addressed the growing number of homeless or near homeless in the community, and he acknowledged the hard work done by Township staff to establish and manage the program. Supervisor Quarnstrom noted new programming to possibly begin in the next 30 days with details of the program coming in August, 2018. He wished everyone a Happy 4th of July.

NEXT MEETING: Special Regular Township Meeting of July 17, 2018; and the Regular Monthly Township meeting of August 7, 2018.
