## **ORDINANCE NO. 2018-1201**

## AN ORDINANCE LEVYING TAXES FOR ALL TOWNSHIP PURPOSES FOR THE CITY OF CHAMPAIGN TOWNSHIP, CHAMPAIGN COUNTY, ILLINOIS FOR THE TAX YEAR 2018, COLLECTIBLE IN 2019

WHEREAS, the Township Trustees of the City of Champaign Township, Champaign, Illinois did on the 17<sup>th</sup> of July 2018, duly adopt the Annual Budget for the said Township for the fiscal year beginning July 1, 2018 and ending June 30, 2019; and

WHEREAS, the Township Trustees have directed that the Township's property tax levy (exclusive of any amount levied for election cost or debt service purposes) for the upcoming year would be \$692,254, such estimated levy being based upon estimated assessed valuation being \$1,743,008,352;

BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE CITY OF CHAMPAIGN TOWNSHIP, CHAMPAIGN COUNTY, ILLINOIS, as follows:

Section 1. That the sum of six hundred ninety-two thousand, two hundred and fifty four dollars, and no cents (\$692,254) is hereby levied upon all property subject to taxation with the Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law for such purposes as:

General Town Fund

General Assistance Fund

Social Security Fund

Illinois Municipal Retirement Fund

For the year 2019.

<u>Section 2.</u> That the amount levied for each object and purpose shall be as follows:
