### APPROVAL OF MINUTES:

May 7, 2019 Regular Township Meeting

Board Member Stock, seconded by Board Member Gladney, moved to approve the minutes. A voice vote was taken; all voted yes. Motion carried.

CORRESPONDENCE: None

APPROVAL OF SUMMARY OF CHECKS WRITTEN – ALL FUNDS, APRIL 2019: April showed the total for the Town Fund was \$70,581.93; General Assistance was \$15,221.78; IMRF was \$4,036.19; and the Social Security Fund was \$740.20. Total expenditures for the month of April 2019 were \$90,580.10. Board Member Stock, seconded by Board Member Gladney, moved to accept and place on file the summary of expenditures. A voice vote was taken on the motion to approve the expenditure report and place it on file; all voted yes. Motion carried.

PUBLIC HEARING: ANNUAL BUDGET AND APPROPRIATION ORDINANCE: After a reading of the intent of the public hearing by Chairperson Feinen, noting publication of the public hearing on Sunday, April 28, 2019 and copies were placed on file with the Township Clerk and at the Township Offices on Monday, April 15, 2019, the public hearing was opened at 7:02 p.m. The public was invited to speak. No one spoke. The public hearing was closed at 7:03 p.m.

## ACTION ON ORDINANCES & RESOLUTIONS

ORDINANCE 2019-0601: Annual Budget and Appropriation Ordinance: Board Member Stock, seconded by Board Member Gladney, moved to adopt the Ordinance. Supervisor Quarnstrom noted this budget entails some increase in programing (General Assistance and Rental Assistance); administrative costs have remained virtually the same; and that further detail is attached to the Ordinance. Board Member Stock questioned the lowered total amounts; and the drop in the Assessor's and Supervisor's salary totals. Chairperson Feinen questioned including the budget attachment as part of the motion. A roll-call vote was taken, all voted yes. Motion carried.

AUDIENCE PARTICIPATION: None

TOWN BOARD AND TOWNSHIP SUPERVISOR'S COMMENT: Supervisor Quarnstrom noted an error on the agenda, the next meeting date should be July 9, 2019, and no meeting will be held July 2, 2019 the week of the holiday. In addition, he noted an increase in the monthly grant amount of General Assistance to families from \$245 (past six years) to \$304; thanked Board Members for ensuring those in need receive assistance needed; and noted how the CU@Work program continues to prosper and the ability to request cleanup via the Township website.

ADJOURNMENT: Board Member Stock, seconded by Board Member Gladney, moved to adjourn. A voice vote was taken on the motion to adjourn; all voted yes. Motion carried.
