Supervisor Quarnstrom noted the tax rate will remain the same,

and growth reflects an increase in the levy based on assessed value in property valuation. A roll-call vote was taken on adoption of the Ordinance, all voted yes. Motion carried.

FY 18-19 TOWNSHIP AUDIT: Supervisor Quarnstrom noted completion of the audit without incident; and that the audit is available for review in the Township Office and on the Township website. Board Member Brix, seconded by Board Member Gladney, moved to accept and place on file the Township Audit. A voice vote was taken; all voted yes. Motion carried.
