**ORDINANCE NO. 2020-1201**

**AN ORDINANCE LEVYING TAXES FOR ALL TOWNSHIP PURPOSES FOR THE CITY OF CHAMPAIGN TOWNSHIP, CHAMPAIGN COUNTY, ILLINOIS FOR THE TAX YEAR 2020, COLLECTIBLE IN 2021**

WHEREAS, the Township Trustees of the City of Champaign Township, Champaign, Illinois did on the 2<sup>nd</sup> of June 2020, duly adopt the Annual Budget for the said Township for the fiscal year beginning July 1, 2020 and ending June 30, 2021; and

WHEREAS, the Township Trustees have directed that the Township's property tax levy (exclusive of any amount levied for election cost or debt service purposes) for the upcoming year would be \$762,711 such estimated levy being based upon estimated assessed valuation being \$1,899,140,026;

BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE CITY OF CHAMPAIGN TOWNSHIP, CHAMPAIGN COUNTY, ILLINOIS, as follows:

Section 1. That the sum of seven hundred and sixty two thousand, seven hundred and eleven dollars, and no cents (\$762,711) is hereby levied upon all property subject to taxation with the Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law for such purposes as:

- General Town Fund
- General Assistance Fund
- Social Security Fund
- Illinois Municipal Retirement Fund

For the year 2020.

Section 2. That the amount levied for each object and purpose shall be as follows:


Section 5. That this Ordinance shall be in full force and effect after its adoption, as provided by law.



ADOPTED this 1st day of December 2020, pursuant to a roll call vote by the Board of Trustees of the City of Champaign Township, Champaign County, Illinois.


