SWEARING IN OF TOWNSHIP SUPERVISOR: Chairperson Feinen swore in Andrew Quarnstrom as Township Supervisor.

APPROVAL OF MINUTES:

June 1, 2021 Regular Township Meeting

Board Member Pianfetti, seconded by Board Member Gladney, moved to approve the minutes. There was no Board Member discussion. A roll-call vote was taken; all voted yes. Motion carried.

CORRESPONDENCE: None

APPROVAL OF SUMMARY OF CHECKS WRITTEN – ALL FUNDS, MAY 2021: May showed the total for the Town Fund was \$71,416.72; General Assistance was \$85,177.17; IMRF was \$12,319.40; and the Social Security Fund was \$1,161.96. Total expenditures for the month of May 2021 were \$170,075.25. Board Member Pianfetti, seconded by Board Member Gladney, moved to approve the expenditures, and place them on file. There was no discussion by Board Members. A roll-call vote was taken; all voted yes. Motion carried.

ORDINANCES AND RESOLUTIONS:

Passed 2021-0701 “An Ordinance Amending the FY 2021/2022 Budget”

Board Member Pianfetti, seconded by Board Member Gladney, moved to adopt the Ordinance. Supervisor Quarnstrom noted the budget amendment will authorize acceptance of a subrecipient grant from the CDBG fund for emergency rental mortgage and utility assistance in the amount of \$91,982.90 for those affected by COVID. There was no discussion by Board Members. A roll-call vote was taken; all voted yes. Motion carried.

Passed 2021-0702 “A Resolution Approving An Intergovernmental Agreement Between The City of Champaign Township And The City Of Champaign”

Board Member Pianfetti, seconded by Board Member Gladney, moved to adopt the Resolution. Supervisor Quarnstrom noted this Resolution allows the Township Supervisor to enter into an agreement to provide CDBG funding of \$91,982.90 as authorized in Ordinance 2021-701, in the upcoming weeks. A roll-call vote was taken; all voted yes. Motion carried.
