### APPROVAL OF MINUTES:

August 3, 2021 Regular Township Meeting

Board Member Pianfetti, seconded by Board Member Gladney, moved to approve the minutes. There was no Board Member discussion. A voice vote was taken; all voted yes. Motion carried.

APPROVAL OF SUMMARY OF CHECKS WRITTEN – ALL FUNDS, JULY 2021: July showed the total for the Town Fund was \$67,509.24; General Assistance was \$82,122.57; IMRF was \$7,901.57; and the Social Security Fund was \$1,174.10. Total expenditures for the month of July 2021 were \$158,707.48. Board Member Pianfetti, seconded by Board Member Gladney, moved to approve the expenditures, and place them on file. A voice vote was taken; all voted yes. Motion carried.

FY20-21 GATA QUARTERLY REPORT: Board Member Pianfetti, seconded by Board Member Gladney, moved to approve the FY20-21 GATA Quarterly Report. Supervisor Quarnstrom noted the extra work Township staff continue to do because of COVID. A voice vote was taken; all voted yes. Motion carried.

Passed                                      2021-0901 “An Ordinance Amending the Annual Budget  
For the Township General Assistance Fund”

Board Member Pianfetti, seconded by Board Member Gladney, moved to adopt the Ordinance. Supervisor Quarnstrom explained this Ordinance to amend the budget will authorize acceptance of an Emergency Solutions (ESG-CV) grant in the amount of \$83,121 to assist those affected by COVID. Supervisor Quarnstrom noted this grant will provide additional mortgage and rental assistance to residents in Champaign County, with \$75,564.90 designated for programmatic usage, and \$7,556.10 designated for administrative usage. Supervisor Quarnstrom also noted these grant funds are in addition to the more than \$600,000 received to date to assist those impacted by COVID. There was no discussion by Board Members. A roll-call vote was taken; all voted yes. Motion carried.

TOWN BOARD AND TOWNSHIP SUPERVISOR’S COMMENT: Chairperson Kyles thanked Township staff for their continued work.

NEXT MEETING: The next Regular Township Meeting will be held on October 5, 2021.
