APPROVAL OF MINUTES:

October 5, 2021 Regular Township Meeting

APPROVAL OF SUMMARY OF CHECKS WRITTEN – ALL FUNDS, SEPTEMBER 2021: September showed the total for the Town Fund was \$109,811.66; General Assistance was \$26,579.62; IMRF was \$8,027.91; and the Social Security Fund was \$1,182.18. ORDINANCES AND RESOLUTIONS:

Passed 2021-1101 “A Resolution Determining the
Amounts of Money Estimated to be
Necessary to Be Raised by the Tax Levy”

Board Member Pianfetti, seconded by Board Member Gladney, moved to adopt the Resolution. Supervisor Quarnstrom noted the proposed estimate of 4.57% is less than the 5% cap from the previous year. He noted there will be a public hearing in December, as well as adoption of the levy in December. A roll-call vote was taken; all voted yes. Motion carried.
