**APPROVAL OF MINUTES:**

November 2, 2021 Regular Township Meeting

Board Member Pianfetti, seconded by Board Member Gladney, moved to approve the minutes. There was no Board Member discussion. A voice vote was taken; all voted yes. Motion carried.

**APPROVAL OF SUMMARY OF CHECKS WRITTEN – ALL FUNDS, OCTOBER 2021:** October showed the total for the Town Fund was \$89,724.11; General Assistance was \$74,109.65; IMRF was \$8,327.29; and the Social Security Fund was \$1,800.77. Total expenditures for the month of October 2021 were \$173,961.82. Board Member Pianfetti, seconded by Board Member Gladney, moved to approve the expenditures, and place them on file. A voice vote was taken; all voted yes. Motion carried.

**PUBLIC HEARING: TOWNSHIP LEVY:**

The public hearing was opened at 7:02 p.m. After a brief explanation of the public hearing by Chairperson Feinen, the public was invited to speak. No one spoke. The hearing was closed at 7:03 p.m.

2021-1201 “An Ordinance levying taxes for all Township purposes for the City of Champaign Township, Champaign County, Illinois for the tax year 2021, collectible in 2022”

Tax Levy Amount: \$797,548

Estimated Assessed Valuation: \$1,911,328,483

Board Member Pianfetti, seconded by Board Member Gladney, moved to adopt the Ordinance. Supervisor Quarnstrom noted the proposed estimated increase of 4.57% is well within the 5% cap. He noted a public hearing was held in November. A roll-call vote was taken; all voted yes. Motion carried.

Board Member Pianfetti, seconded by Board Member Gladney, moved to accept the audit and place it on file. Supervisor Quarnstrom thanked Finance staff for their assistance and guidance. A roll-call vote was taken; all voted yes. Motion carried.
