SUBJECT: Fiscal Year 2021/2022 Budget Amendment, Ordinance 2022-0401

**A. Introduction:** The purpose of this Ordinance is to amend the FY 2021/2022 budget to increase revenues by \$19,476.88 in the General Assistance Miscellaneous Revenue Account (803-48000) and increase expenditures by \$19,476.88 in the General Assistance Emergency Grant Account (80380810-52690).

**B. Recommended Action**: The Township Administration recommends approval of this Ordinance.

## C. Summary:

The City of Champaign Township applied to be a subrecipient of the City of Champaign for a Community Development Block Grant (CDBG) in 2021. This budget amendment reflects an additional \$19,476.88 that is being added to the original CDBG subrecipient agreement. This grant is specific to providing housing related costs to those negatively affected by the Covid virus. The City of Champaign Township will provide up to \$1,800.00 of rental or mortgage assistance to those financially affected by the Covid-19 virus.

## D. Background:

- **1. Emergency Rental Assistance:** The City of Champaign Township implemented an Emergency Rental Assistance program in 2018. Since then, the program has expanded in scope and partnership and the Township no works closely with Cunningham Township and Regional Planning to operate a no wrong door concept for rental assistance in Champaign County.
- **2. Community Development Block Grant:** The Community Development Block Grant is an annual grant from the United States Department of Housing and Urban Development given to states, cities, and counties. Intended to help provide decent housing and a suitable living environment for primarily lowand moderate-income persons. The City of Champaign received the CDBG-Covid grant and in turn the City of Champaign Township became a sub-grantee for Covid specific rental and mortgage assistance.

### E. Alternatives:

- 1. Approve Ordinance 2022-0401, An Ordinance Amending the City of Champaign Township Budget and Appropriation for FY 2021/2022 in the amount of \$19,476.88.
- 2. Do not approve Ordinance 2022-0401, An Ordinance Amending the City of Champaign Township Budget and Appropriation for FY 2021/2022 and provide staff with alternative direction.

#### F. Discussion of Alternatives:

**Alternative 1** approves Ordinance 2022-0401 and allows the Township to receive \$19,476.88 as a subgrantee of the City of Champaign for the Community Development Block Grant.

## a. Advantages

 Approving Ordinance 2022-0401 will allow the Township to continue it's rental assistance to renters and owners that have been financially affected by Covid 19. As a grant recipient, the Township will be able to provide Covid specific assistance with the CDBG grant to between 10 and 15 households in the City of Champaign.

## b. Disadvantages

-No disadvantage to approving Ordinance 2022-0401.

- **H. Budget Impact:** Should the Ordinance be approved; the Township will receive \$19,476.88 in which \$19,476.88 will be used solely for rental and mortgage assistance.
- **I. Staffing Impact**: Approximately 1 hour of staff time was needed to write this report. In addition, approximately 20 hours of additional case management will be required by the Township's Emergency Assistance Caseworker over the next year.
