APPROVAL OF MINUTES:

June 7, 2022 Regular Township Meeting

Board Member Pianfetti, seconded by Board Member Gladney, moved to approve the minutes. There was no Board Member discussion. A voice vote was taken; all voted yes. Motion carried.

PUBLIC HEARING – ANNUAL BUDGET: Chairperson Feinen gave a brief explanation of the purpose of the public hearing, opening the public hearing at 7:01 p.m. and invited the public to speak. No one spoke. The public hearing was closed at 7:02 p.m.

APPROVAL OF SUMMARY OF EXPENDITURES – ALL FUNDS, MAY 2022: May showed the total for the Town Fund was \$61,274.75; General Assistance was \$33,208.10; IMRF was \$11,046.47; and the Social Security Fund was \$1,229.39. Total expenditures for the month of May 2022 were \$106,758.71. Board Member Pianfetti, seconded by Board Member Gladney, moved to approve the expenditures, and place them on file. A voice vote was taken; all voted yes. Motion carried.

Board Member Pianfetti, seconded by Board Member Gladney, moved to adopt the Ordinance. There was no discussion by Board Members. A roll-call vote was taken, all voted yes.
