APPROVAL OF SUMMARY OF EXPENDITURES – ALL FUNDS, OCTOBER 2022: October showed the total for the Town Fund was \$56,428.01; General Assistance was \$12,860.87; IMRF was \$7,312.49; and the Social Security Fund was \$1,231.05. Total expenditures for the month of October 2022 were \$77,832.42. Board Member Pianfetti, seconded by Board Member Gladney, moved to approve the expenditures, and place them on file.
