### APPROVAL OF MINUTES:

APPROVAL OF SUMMARY OF EXPENDITURES – ALL FUNDS, DECEMBER 2022: December showed the total for the Town Fund was \$143,040.37; General Assistance was \$16,098.18; Shelter Fund was \$5,744.40; Social Security Fund was \$1,319.58; and IMRF was \$8,928.55. Total expenditures for the month of December 2022 were \$175,131.08. Board Member Pianfetti, seconded by Board Member Gladney, moved to approve the expenditures, and place them on file. A roll-call vote was taken; all voted yes. Motion carried.

### TOWNSHIP COMPTROLLER REPORT:

Board Member Pianfetti, seconded by Board Member Gladney, moved to place on file the Township Comptroller Report. A roll-call vote was taken; all voted yes. Motion carried.

TOWNSHIP ASSESSOR VACANCY PROCESS UPDATE-INFORMATION ONLY:

Township Attorney Yu noted that the Town Clerk received a letter from Paul Faraci, Township Assessor, noting his resignation effective March 7, 2023. Attorney Yu also indicated that the replacement plan will follow the process as outlined in the Statute, which includes filling the vacancy either by appointment or by contract. Information regarding the application process is available on the Township's website. Applications must be submitted to the Town Clerk by February 21, 2023, and staff will review and provide a recommendation at the March 7, 2023, Township meeting.
