APPROVAL OF SUMMARY OF EXPENDITURES – ALL FUNDS, FEBRUARY 2023:

February showed the total for the Town Fund was \$165,781.80; General Assistance was \$26,429.33; Shelter Fund was \$14,385.48; Social Security Fund was \$14,385.48; and IMRF was \$17,137.67. Total expenditures for the month of February 2023 were \$225,053.86. Board Member Pianfetti, seconded by Board Member Gladney, moved to approve the expenditures, and place them on file. A voice vote was taken; all voted yes. Motion carried.

ORDINANCES & RESOLUTIONS:

Passed 2023-0401 “CU AT WORK

Memorandum of Understanding”

Board Member Pianfetti, seconded by Board Member Gladney, moved to adopt the Resolution. Supervisor Quarnstrom noted the annual cooperative agreement provides case management, administrative support, etc. A roll-call vote was taken; all voted yes. Motion carried.

AUDIENCE PARTICIPATION: None

TOWN BOARD AND TOWNSHIP SUPERVISOR’S COMMENT: Supervisor Quarnstrom noted that the Township has been identified as a recipient of \$750,000 from the City of Urbana’s ARPA funding. This funding will be used to cover personnel costs for the shelter for an additional seven months. Supervisor Quarnstrom also noted that the shelter has been operating with a waiting list every night since the opening on December 12, 2022; he thanked all partners and community members for their feedback; and commended staff for all of their work.
