APPROVAL OF SUMMARY OF EXPENDITURES – ALL FUNDS, MAY 2023:

May showed the total for the Town Fund was \$276,139.82; General Assistance was \$29,487.04; Shelter Fund was \$50,586.48; Social Security Fund was \$1,460.44; and IMRF was \$18,264.40. Total expenditures for the month of May 2023 were \$276,139.82. Board Member Pianfetti, seconded by Board Member Gladney, moved to approve the expenditures, and place them on file. A voice vote was taken; all voted yes. Motion carried.

COMMITTEE INTRODUCTION: In accordance with Section 10(b) of the Decennial Committee on Local Government Efficiency Act, 50 ILCS 70/1 *et seq*, Supervisor Quarnstrom explained that the committee membership should include the elected or appointed members of the governing board, including the Supervisor and at least two township residents appointed by the Supervisor. Supervisor Quarnstrom indicated he was still working to identify committee members.

COMMITTEE GOALS: Supervisor Quarnstrom explained that the Act requires any local government that levies a tax (other than a municipality or county) to file a report to its County summarizing its work within eighteen (18) months after the committee's first meeting. Additionally, the committee must meet at least three (3) times within that time period.

Committee members comments included confirmation regarding the number of times the committee is required to meet, and clarifying if the current meeting counted towards the three (3) meeting requirement.

COMMITTEE SCHEDULE: Tentatively, additional Decennial Committee meetings are scheduled for September 5, 2023, and November 7, 2023.

AUDIENCE PARTICIPATION: There was no audience participation. Supervisor Quarnstrom noted that the Act requires that the Township provide an opportunity for participants to provide feedback. Supervisor Quarnstrom asked that feedback be provided at cctownship.com. NEXT MEETING: The next Decennial Committee meeting will be held on September 5, 2023.

Supervisor Quarnstrom adjourned the committee meeting back to the Town Board meeting at 7:12 p.m.
