APPROVAL OF MINUTES:

Board Member Pianfetti, seconded by Board Member Gladney, moved to approve the minutes. There was no Board Member discussion. A voice vote was taken; all voted yes. Motion carried.

APPROVAL OF SUMMARY OF EXPENDITURES – ALL FUNDS, SEPTEMBER 2023:

September showed the total for the Town Fund was \$317,931.64; General Assistance was \$31,146.99; Shelter Fund was \$17,973.69; Social Security Fund was \$1,898.57; and IMRF was \$20,407.71. Total expenditures for the month of September 2023 were \$389,358.60. Board Member Pianfetti, seconded by Board Member Gladney, moved to approve the expenditures, and place them on file. A voice vote was taken; all voted yes. Motion carried.

FY 23-24 1ST QUARTER REPORT:

Supervisor Quarnstrom noted the report highlights the Strides effort and the overall continued work of the Township; he also provided kudos to Deputy Supervisor

VanAntwerp for her work on the report. A voice vote was taken; all voted yes. Motion carried.

ORDINANCES & RESOLUTIONS:

Passed 2023-1011 "A Resolution Determining the Amounts of Money Estimated to be Necessary to be Raised by the Tax Levy"

Board Member Pianfetti, seconded by Board Member Gladney, moved to adopt the Resolution. Supervisor Quarnstrom noted a proposed estimate of 11%. He also noted there will be a public hearing in December, followed by adoption of the levy. Chairperson Feinen's technical question included whether the current levy amount includes sufficient funding for the Strides shelter. Additionally, the following member of the audience spoke: Martel Miller, Champaign. A roll-call vote was taken, all voted yes.

TOWN BOARD AND TOWNSHIP SUPERVISOR'S COMMENT:

Board Member Pianfetti noted the Centennial Interact Club is holding a drive for the shelter. Supervisor Quarnstrom noted there are several community groups and volunteers working to raise support for the shelter; COVID spread in the shelter; and staffing shortages.
