

Personal Statement

Please write a brief statement concerning why you are interested in serving Township Supervisor.

To start out with, in 2016 I considered retirement. I didn't like it so I turned to an occupation that fulfilled my desire to feel useful and return something to the community I live in and I have been in the business of encouraging recovery and helping guide those who need assistance back into productive lives in their various communities.

I had volunteer experience in Virginia on the board of a non-profit provider of housing and services for mentally ill and challenged persons followed by an appointed position on the Arlington County Community Services Board. Community services boards (CSBs) are the single points of entry into publicly funded mental health, developmental, and substance abuse services in Virginia. I was heavily involved during the early 1980s in the community education and consensus building efforts that led to Arlingtons first shelter and transitional housing facility involving funding through the Arlington Department of Human Services..

I also have personal experience with Alcohol and Substance abuse and have been a sober member of AA for over 20 years.

While working as a Realtor in Champaign I came to know Melany Jackson as she was starting CU at Home and I wholeheartedly support her original vision of housing the most vulnerable and most difficult among the homeless.

I was excited when I learned of the Township plan to open a low barrier shelter and proud to be on board and involved in the opening of Strides a little over a year ago.

Over the course of the first year I've come to learn the breadth and depth of the homeless problem in Champaign and east central Illinois and it is far greater than I realized. I believe that the Township, inder its constitutional charge to provide general assistance, is uniquely positioned to play a vital role in the effort to put an end to homelessness in Champaign and the surrounding area.

As Supervisor I believe I can bring both perspective and experience to the Township in this area and I want the opportunity to help guide the efforts to provide safety, security and shelter to the most vulnerable among our citizens and enhance the contributions of all the various supportive services being brought to bear on the effort to eradicate homelessness.

Finally, I am well aware that Strides shelter is not the only thing the Township does. However, it is the driver that more than quadrupled the number of employees and tripled the budget.

Supplemental Questions

1. What do you see as the most pressing need in the City of Champaign Township? Why?

The Township needs to clarify and expand the meaning of "general assistance to the indigent". In the face of an affordable housing crisis and an exploding homeless population the Township has found itself in the shelter business. In the low barrier shelter business that includes shelter guests that may have severe mental and emotional health issues as well as profound substance addictions. It means some guests that face barriers to housing that are so high they may never leave the shelter. There is an opportunity here to provide more than just a roof and a bed but that means wrapping supportive services around the location, a much more complex endevor than just providing shelter.

Low barrier shelters are the last stop for many guests before jail because there are not adequate mental health and substance abuse services and housing for these populations.. Low barrier shelters are in danger of becoming society's default mental health warehouses... without the resources and skills to deal with this population.

2. Prior to learning about the Township Supervisor vacancy, have you ever been to a Town Board meeting or City Council meeting? If yes, what was the topic or topics you were interested in?

Yes, but some years ago when CU at Home was just beginning.

Also a couple of land use issues and during the time when the downtown YMCA was considering and ultimately moved out to Staley Road. As a neighbor and patron I was intensly interested in anything that could have been done to keep the facility downtown. I've learned over the years that when trying to influence change one does what one can and accepts the result, whatever it may be.

3. What in your qualifications or background make you the right person for this appointment?

A lifetime of experience in a wide variety of roles, some successful and some less so. An open mind and curiousity coupled with the willingness to work within the constraints' of whatever situation I find myself in.

4. What are some of your long-range objectives for the City of Champaign Township?

I'd like to see it in a leadership role in the provision of services to those who need them most, i.e. "general assistance to qualifying residents". I believe the Assessor's shop is well fixed and the focus of the Supervisor should be clearly in the assistance to the indigent and, particularly those who need assistance in achieving and maintaining housing.

5. What do you see as successful qualities of a Township Supervisor?

Formost, the ability to listen and negotiate effective compromise. I have a vision for the Township's role in providing services but I am also a pragmatist and understand that for anything to be accomplished the Township will have to work within budget and with the resources available. It is an executive as well as leadership position.

6. What is the role of a Township Supervisor?

To set direction, goals and asperations for the Township and to use and trust staff to effectively execute the actions necessary to achieve as much as possible. To be the community face of the Township.

7. Give us an example of a time you solved a difficult problem or issue,

Lets step back some time to when I was doing marketing consulting. I had a client that manufactured thread sold wholesale to major furniture and automotive manufacturers. As an aside, they were also the only maker of the large wicks that are burnt alongside railroad tracks so that the rails can be bent. They hired me to research and develop marketing lists to be used to test the feasibility of producing smaller packages of thread for sale to furniture and upholstery repair shops. I did the market research and developed the lists, but I also analysed the production, marketing and delivery plans that went along with their scheme. My analysis found that scaling up a new division to do this work and breaking their product down to retail quantities, warehousing, packaging and fulfulling orders and so forth would actually distract from their core business, thread spools that were delivered on railroad cars, would require a complete revision of theiir accounting systems and would actually produce less profit than their core business. What at a casual glance looked like an easy way to extend their reach simply wasn't and I advised that they drop the project, which would have been a nice revenue producer for my company but not in their best interest. They thanked me, paid a quit fee and recommended me to other businesses in need of my services.

8. How would you support the Strides shelter? What are your ideas for long term funding and hiring and retention of employees for the shelter?

Ouch! Grant funds will run out. Additional grants and donations can be solicited but this will ultimately require taxpayer participation and the ongoing need for this shelter will have to be sold to the community.

One alternative that might be worth exploring would be the sale of beds on a contract basis to other service providers like hospitals, rehabs, law enforcement, jails and prisons as a safe haven on release. The Salvation Army had a percentage of their beds under contract to the Vererans Administration when they were operating the Stepping Stones shelter at their North Market location. The issue with this approach is that low barrier may not be acceptable to the organizations that might contract beds.

Shelter staff is a frustrating, demanding, difficult and sometimes dirty job. No guest wants to be in a shelter and the tension level is always there. Almost all homeless persons suffer from PTSD and most have other mental or emotional issues. Their world is not the same as ours. Impatience and angry outbursts are just part of every day and staff are always being tested on their deescalation skills. While the few successful transitions to housing are rewarding the larger number of failures is depressing – and some will die in or around the shelter. Shelter staff in a low barrier setting may be one of the hardest jobs in public social service,

I believe recruiting has to be absolutely rigorously honest and there are some people who should not work in the field. Pay is not an issue, the shelters pay scales are very competitive. Burnout is the issue. Shelter staff need to take advantage of counseling services. There is an EAP but few staff seem aware of it and fewer take advantage. Staff shortfalls and absenteeism burden everyone.


More staff to cover the gaps might help. Visible, committed leadership might also, but in a 24X7 setting that means management will have to put in a lot of hours at all hours of the day and night. To my knowledge no one has complete answers so we just keep trying.
