**APPROVAL OF SUMMARY OF EXPENDITURES – ALL FUNDS, DECEMBER 2023:**

December showed the total for the Town Fund was \$239,119.62; General Assistance was \$36,138.03; Shelter Fund was \$17,261.49; Social Security Fund was \$1,019.94; and IMRF was \$19,624.29. Total expenditures for the month of December 2023 were \$313,163.37. Board Member Pianfetti, seconded by Board Member Gladney, moved to approve the expenditures, and place them on file. A voice vote was taken; all voted yes. Motion carried.

**Acceptance of Township Supervisor Resignation:**

Board Member Pianfetti, seconded by Board Member Gladney, moved to accept Supervisor Quarnstrom’s resignation. Supervisor Quarnstrom thanked the Board for their

support and expressed joy for the time served. Supervisor Quarnstrom also noted the continued need for Township services. Board member comments included appreciation to Supervisor Quarnstrom for his work; the ongoing efforts to assist those in need; continued efforts to make a difference in the community, specifically the Strides shelter and the C-U at Work program. A voice vote was taken; all voted yes. Motion carried.

Oath of Office of new Township Supervisor Kyle Patterson:

Chairperson Feinen issued the oath of office to Kyle Patterson, Township Supervisor. Supervisor Patterson thanked the Board and acknowledged the work to be done. Supervisor Petterson also expressed excitement to start in the Supervisor role.
