SUMMARY OF EXPENDITURES (NOVEMBER 2025):

November showed the total for the Town Fund was \$178,726.53; General Assistance was \$55,608.15; Shelter Fund was \$23,584.53; IMRF was \$13,077.97; and the Social Security Fund was \$1,206.12. Total expenditures for the month of November 2025 were \$272,203.30. Board Member Pianfetti, seconded by Board Member Gladney, moved to approve the expenditures, and place them on file. A voice vote was taken; all voted yes.
