

ORDINANCE NO. 2025-1201

AN ORDINANCE LEVYING TAXES FOR ALL TOWNSHIP PURPOSES FOR THE CITY OF CHAMPAIGN TOWNSHIP, CHAMPAIGN COUNTY, ILLINOIS FOR THE TAX YEAR 2025, COLLECTIBLE IN 2026

WHEREAS, the Township Trustees of the City of Champaign Township, Champaign, Illinois did on the 30th day of September 2025, duly adopt the Annual Budget for the said Township for the fiscal year beginning July 1, 2024, and ending June 30, 2025; and

WHEREAS, the Township Trustees have directed that the Township’s property tax levy (exclusive of any amount levied for election cost or debt service purposes) for the upcoming year would be \$1,092,401 such estimated levy being based upon estimated assessed valuation being \$2,761,679,068.

BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE CITY OF CHAMPAIGN TOWNSHIP, CHAMPAIGN COUNTY, ILLINOIS, as follows:

Section 1. That the sum of one million, ninety-two thousand, four hundred one dollars, and no cents (\$1,092,401) is hereby levied upon all property subject to taxation with the Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law for such purposes as:

- General Town Fund
- General Assistance Fund
- Social Security Fund
- Illinois Municipal Retirement Fund

For the year 2025.

Section 2. That the amount levied for each object and purpose shall be as follows:

Section 3. That the Town Clerk shall make and file with the County Clerk of said County of Champaign, on or before the last Tuesday of December 2025, a duly certified copy of this Ordinance.

Section 4. That if any section, subdivision, or sentence of this Ordinance shall for any reason be held invalid or unconstitutional, such finding shall not affect the validity of the remaining portion of this Ordinance.

Section 5. That this Ordinance shall be in full force and effect after its adoption, as provided by law.

Section 6. That the Town Clerk is hereby directed to send a copy of this Ordinance to Corrine Jordan, Supervisor of the City of Champaign Township, and to Thomas Yu, Township Attorney.

Section 7. That the Town Board Chair shall certify that the Township has complied with the requirements of the Truth in Taxation Act (35ILCS 200/18-55 *et seq.*) in adopting this tax levy.
